Strategic Plan Objective CER2.1: We have now developed a pre-college pathways map, which is shown in the Prezi presentation at this link: <a href="https://prezi.com/view/UGcq8oJqAmUuGqSZVjHb/">https://prezi.com/view/UGcq8oJqAmUuGqSZVjHb/</a>. This illustrates the increasingly coherent, integrated approach to engaging high school students in the college experience in a way that builds their understanding and academic preparedness to be successful at College of Marin and beyond. Additionally, a draft satellite course policy/checklist has been developed and is being shared with partner high school principals for discussion and feedback. It will be finalized later this spring.

Strategic Plan Objective CER2.2: COMPASS is the College's flagship program relating to this objective and currently has roughly 250 participants across five local high schools. COMPASS continues to evolve and this summer we will have a full year of college success data for the first cohort of students. Additionally, College of Marin is a key component of the Sausalito-Marin City School District attorney general-mandated desegregation plan. Specifically, the College will provide:

- College and career counseling support for the "impacted students" who attended SMCSD from 2013 (some are at Tam HS now)
- o "COMPASS Prep" support for middle school students at MLK in partnership with 10KD, Bridge the Gap, and Marin Promise Partnership
- Automatic admission to Tam COMPASS program
- STEM activities with 8<sup>th</sup> grade class

All of this work is supported by the other pre-college pathways components, including and through Summer Bridge, HUM 101, and learning community involvement by many of the students in the specified demographic.
