Strategic Plan Objective CS2.2:

We have engaged a consultant to help with completion of the Facilities Master Plan. On Friday, January 17, 2020 we received an outline from the consultant detailing the two options for the FMP. Option 1 is to do a Facilities Master Plan Update and Option 2 is to do a new Facilities Master Plan. Greg Nelson will be reviewing the slide presentation with the President's Cabinet to get guidance on which approach we will follow. Once a decision is made we will continue working with the consultant to finalize the scope and start the master planning process.

Strategic Plan Objective CS2.3:

The Measure B projects all are designed to meet the State of California Cal Green standards. These design standards involve the use efficient light fixtures and building systems, water efficient fixtures, design of low water use landscaping. Additional site features include design of onsite retention systems to minimize stormwater runoff, use of permeable surfaces. Our new facilities are solar ready and will be evaluated at a future date for solar installation depending on costs and feasibility.
