Strategic Plan Objective IP2.1: Several efforts to align curriculum with K-12 are under way. Most notably,

- a. College faculty are working with high school faculty and others to develop a project-based summer career academy focused on the development and use of math concepts in an effort to reduce 'math loss' between grades and keep more students on track for A-G completion.
- b. College faculty and administrators are working with high school faculty and administrators to improve ESL instruction, which is a major barrier to college success. While this issue will take several years to fundamentally change, the College will pilot an expanded ESL-focused Summer Bridge in 2020 as an interim measure.
- c. Plans are underway to engage College and high school English faculty in the next school year.
- d. College of Marin was instrumental in Marin County Office of Education obtaining \$1.2M in K-12 Strong Workforce grant funds. The College will share a position with MCOE designed to articulate curriculum, expand pathways to certificate and degree beginning with high school, and promote opportunities at College of Marin.
